

**BISHOP PAIUTE TRIBAL COURT
INSTRUCTIONS FOR COMPLETING THE
APPLICATION FOR TEMPORARY PROTECTION ORDER**

DIRECTIONS: The PLAINTIFF is the person requesting the Temporary Protection Order (TPO); the DEFENDANT is the person you are requesting protection from.

INSTRUCTIONS:

- (1) Enter the name of the Plaintiff (person requesting the TPO).
- (2) Enter the name of the Defendant (person you are requesting protection from).
- (3) This number will be assigned by the Court Clerk.
- (4) In questions #2: Check either Yes or No. If Yes, attach copy of requested papers.
- (5) In question #3, after reading the instructions for Registration of Out-Of-State Restraining Order check Yes or No.
- (6) Enter Plaintiff's physical address.
- (7) If Plaintiff is employed and wants the Defendant to stay away from his/her work place during the Plaintiff's work hours, enter the name of the employer and physical address.
- (8) If Plaintiff is attending school and wants the Defendant to stay away from his/her school while Plaintiff is attending class, enter the name of the school and physical address.
- (9) Enter the name and physical address of other places frequented by Plaintiff that he/she wants the Defendant to stay away from when Plaintiff is at those places.
- (10) Describe what has happened or what the Plaintiff is afraid may happen that has prompted Plaintiff to request a Temporary Protective Order. BE SPECIFIC.
- (11) Enter the names of family members or other persons that are to be included in this Temporary Protection Order.
- (12) Enter other relief you are requesting, BE SPECIFIC.
- (13) Enter Defendant's physical address.
- (14) Enter Defendant's mailing address.
- (15) Enter the date the application is being signed in front of the Court Clerk.
- (16) Signature of the Plaintiff in front of the Court Clerk.
- (17) Print Plaintiff's name.
- (18) Enter Plaintiff's telephone number.
- (19) The Court Clerk will sign and date the paperwork after the fee is paid or an Application for Fee Waiver has been approved.

The Court Clerk will File the paperwork and give you a copy. The Court Clerk will fax the application to the Judge. The Judge will review the application and, if warranted, issue a Temporary Protection Order that will be in effect until the court date.
